MEMBERSHIP CATEGORIES

1 FULL: age over 18

Seven days unrestricted play.

2 SEVEN DAY RESTRICTED

May play golf at any time except before noon on weekends and public holidays.

3 FIVE DAY

Playing golf is restricted to Monday to Fridays.

4 OVERSEAS

Must be both currently resident and in full playing membership of a recognised Golf Club outside the UK.

5 COUNTRY

Must not reside within 75 miles of the Club. No restriction on playing golf, other than main competitions.

6 HOUSE

May use all of the Club's facilities, including the putting green, but must pay a full green fee when playing golf. House members may also use bars, restaurant and take advantage of functions and hire facilities.

7 JUNIOR

Aged up to 17. May play golf at any time except before noon on weekends and public holidays.
